Bank Orange collects this personal information from you for these purposes:

- to verify information contained in your completed Questionnaire
- to assess whether you are a fit and proper person to be a responsible person of Bank Orange as an Authorised Deposit-taking Institution under the Banking Act

We also collect information about you from:

- the character referees you nominate in your completed Questionnaire
- other persons and organisations disclosed in your completed Questionnaire, such as previous employees, professional and industry bodies of which you may have been a member, business associates, educational institutions
- the Australian Federal Police

If you do not give us the personal information we require we will not be able to assess your application.

If your application is not successful we will immediately destroy your personal information. If your application is successful:

- the law requires us to retain this information for 7 years
- we may disclose your information to the Australian Prudential Regulation Authority.
